Qualifications

Applicants must be high school seniors or undergraduate students of a University, College, or Technical College.

Applicants selected will be notified by the first week of May, 2012, at which time we will discuss arrangements for your attendance at the Grand Court Opening ceremonies which will be held Thursday, May 17, 2012 at the Holiday Inn Columbus-Worthington 7007 N High Street, Worthington, Ohio.

Instructions

All application forms must be printed or typed.

Respond to all questions on the application, entering N/A if “not applicable”.

Attachments:

At the top of each attachment to your application, ensure that your full name and address are clearly visible.

High School transcripts are required from ALL high school applicants. If you have completed advanced schooling, you must submit transcripts from your school(s). If you are unable to obtain a transcript, secure an affidavit from a school official attesting to your scholastic standing.

Submit a **Financial Plan** for the upcoming school year. Include an estimate of expenses (e.g., tuition, fees, room and board, transportation, books) and planned income (e.g., your earnings, portion from your savings and investments, parental assistance, and other scholarships). **How**

are you personally helping yourself financially? How will your expenses for school be covered?

Include current Personal Reference letters from two (2) sources dated within the last year (not relatives).

Compose a letter describing your extracurricular activities and outside interests, listing the offices held and awards earned during high school and college.

Filing Deadline: Submit the application with attachments to the Chairperson of the Scholarship Committee postmarked no later than April 1, 2012.
