2. Will be honored by any Grand Office I might receive and any disagreement over the office will be grounds for removal of that office.
3. Learn all ritualistic work that is required.
4. Attend Grand Receptions, Constitutions and Institutions whenever possible.
5. Abide by the dress code of the Ohio Grand Assembly.
6. Promote PEACE and HARMONY throughout the State.
7. Will try to have a positive and cheerful disposition at all times.
8. Will abide by the Statutes of Supreme Assembly and Ohio Grand Assembly.
9. Will always set a good example and not talk about my Rainbow Sisters or spread gossip.
10. Will not participate in any conduct unbecoming a Rainbow Girl as stated in but not limited to the Supreme Statutes, Section 30.

OHIO GRAND ASSEMBLY

Grand Deputies will recommend girls for all appointed Grand Floor Offices, Grand Auxiliary Offices and Grand Representatives.

1. Only PAST WORTHY ADVISORS OR WORTHY ADVISORS at the time of Grand Assembly, who have not reached Majority Age (20) and are in good standing in their Assembly, are eligible for Grand Appointments.
A. The exception to this would be: A Worthy Associate Advisor at the time of Grand Assembly would be eligible to receive an Appointment as Grand Representative or the Aide to the Grand Worthy Advisor.
2. An Assembly, having an elected Grand Floor Office or an Appointed Grand Office, will not receive a Grand Appointment the following year until all other eligible Assemblies have been considered, and then only if there are still vacancies.
3. A previous appointment does not disqualify a Past Worthy Advisor from receiving another appointment. However, first time recommendations will have first consideration. A girl NEED NOT have served her Assembly more than once as Worthy Advisor.
4. Any Past Grand Appointed Officer is eligible, with the approval of her Grand Deputy, Advisory Board and the Interview Committee, to seek an elective office.
5. If a girl seeking an elected office is defeated, she may , if offices are available, be appointed as a Grand Auxiliary Officer or Grand Representative. She will be informed of this at the time of her interview for her information and consent.
6. An elected Grand Officer is not eligible for a future Grand Appointment.
7. A girl must be registered FULL TIME and housed by the housing committee to receive a Grand Appointment.
8. The Grand Worthy Advisor cannot be from the same District two consecutive years.
